## **Old Business**

#### Flock Safety:

Charles gave an update on Flock Safety. About 15% of the photos aren't showing a visible license plate. He and Debbie will continue to work with Flock Safety to fix this.

## **Outer Wall/Vine Removal:**

More sections of the outer wall need removal of dead vine or vine trimming. In the sections where the dead vine has already been removed (near Casey and Lowell) the wall needs to be pressure washed, primed, and painted. Debbie will hire a pressure washer for the job, and paint and primer will be purchased. Rick Armstrong has offered to prime and paint for no charge.

In the areas where the vine is alive and growing, the vines need to be trimmed two additional times per year (for a total of three times per year). Debbie is awaiting a quote on this from Clipper Dean.

#### **Audit:**

Trustees discussed whether to do a full audit (estimated cost \$2400) versus a financial compilation (estimated cost \$800) using King and Walker. Our revenues are less than \$50,000 per fiscal year, which qualifies us to do the compilation. Pine Hollow budgets an amount close to \$800 for this service. Treasurer Nees keeps all receipts, canceled checks, and monthly bank statements for submission to King and Walker. These documents will be provided to King and Walker for the FY ending September 30, 2022. Required letters will be mailed to each homeowner. Trustees voted 6-0 to not have a full audit.

## **Change of meeting time and location:**

The trustees agreed to keep the current meeting time. The location will be changed to 12901 Lazy Pine Place, Tampa, FL 33624. The neighborhood sign will be updated as well as the Tampa Bay Times notice.
